Message from the Provincial



Collaboration is a must

Dear Brothers,

One of the most important instructions of GC 36 is a clear direction regarding the manner of our governance and the way of carrying out our ministries. It has emphasized the importance of collaboration. Let us recall briefly the historical development of this concept in the recent years.

GC 34 says that "all those engaged in the work should exercise co-responsibility and be engaged in discernment and participative decision making where it is appropriate" (D.13, n.13). GC 35 says that collaboration "expresses our true identity as members of the Church, the complementarity of our diverse calls to holiness, our mutual responsibility for the mission of Christ, our desire to join people of good will in the service of the human family, and the coming of the Kingdom of God" (GC 35, D.6, n.30). GC 36 re-emphasizes the above instructions and "recognizes the decisive role of our partners in the vitality of the Society's mission today...." (D.2, n. 6).

Further, in the document on "Our Life and Mission", GC 36 says: "Collaboration with others is the only way the Society of Jesus can fulfil the mission entrusted to her. This partnership in mission includes those with whom we share Christian faith, those who belong to different religions, and women and men of good will, who, like us, desire to collaborate with Christ's reconciling work". (D.1, n. 36). Our New Superior General, Fr. Arturo Sosa, in his homily of October 15, 2016 declares that the Jesuits are "called to the mission of Jesus Christ, that does not belong to us exclusively, but that we share with so many men and women consecrated to the service of others". Further, in his talk to the JCSA on February 23, 2017, Fr Arturo Sosa, stated emphatically: "...collaboration with others is the only way the Society of Jesus can fulfill its mission. The magnitude and interconnectedness of the problems that affect humanity and challenge the mission of the Church and the Society are such, that only by working together can we contribute effectively to their solution".

GC 36 also recognizes some of the difficulties faced by the members of the Society in implementing this new approach, while acknowledging the remarkable progress made in this regard. It says that the challenges and difficulties may be because of our lack of imagination and courage or "they may come from inhibitions arising from our social contexts or even from local clerical practices. A particular difficulty can be the lack of genuine collaboration among Jesuits – individuals, institutions, communities, Provinces, and Conferences". (D. 2, n.7). It instructs us in clear terms that "inclusive discernment and ongoing planning and evaluation of our efforts to go beyond the obstacles is required in order to mainstream the participation of mission partners further in various levels of the Society's apostolic activities and governance". (D. 2, n.7).

In this spirit, let us look at our own situation in the Province, in promoting genuine collaboration wherever we work – the efforts, their partial successes, the reluctance on the part of many of us, the resistance by those who are afraid of losing their chances to hold positions of power, the lack of training and orientation on the part of the collaborators, the strong culture of clericalism etc. Let us have the courage to examine our inner disposition in this regard and learn to move gradually in the line of what GC 36 clearly instructs us to do. As genuine followers of St. Ignatius, we have only one option – the promotion of collaboration among the mission partners and sharing with them joyfully the various responsibilities with which a large number of the Jesuits are burdened and even over-burdened today. Let us learn to trust the partners, to allow them to share responsibilities and to take decisions within a clear framework and system. Let us also take steps to train and orient the mission partners, so that they understand the real meaning of collaboration in carrying out the Jesuit ministries and mission.

Fr General's talk to the South Asian Provincials

23 February 2017

(Excerpts)



General Comments

We are called to move from a province vision to a universal vision. A universal vision means a tension between the local and the global. The universal vision is impossible without local roots. The local apostolate makes sense in the context of the universal mission. Discernment is the key to mediate the relationship between the local and the universal. The JCSA is an excellent forum and opportunity to carry out this common responsibility and for discerning how to concretize this universal mission for South Asia.

I am happy to hear about the process of “Re-Orienting for Greater Apostolic Effectiveness (REGAE)” started in 2015, with the hope for a long-term vision and widespread participation of the Jesuits of the South Asian Assistency. A process has been put in motion, please do not stop it. Processes need to mature. The kind of processes we are promoting come from the timely prompting of the Holy Spirit, and not from ourselves.

Life-Mission Challenges

For GC 36, Life and Mission are deeply interconnected. For us, as Christians and Jesuits, Life and Mission are two sides of the same coin. The first step in the Ignatian Spiritual Exercises is to imbibe the spirit of the Principle and Foundation. That is: To gain the inner freedom that enables spiritual indifference as a condition for discernment and decision-making. Indifference is necessary to be available for mission and is the result of a genuine spiritual life.

The invitation to ongoing conversion and renewal of our spiritual life is a perennial reality. The Spiritual Animation Process (SAP) has taken care of this important dimension of our Life-Mission. Discernment, as a way of decision-making, is a challenge. Discernment is not only to search God's will in our individual lives but also to find God's will together. Discernment was Jesus' way of proceeding during his life. The complexity and magnitude of the present context demand more and better discernment so as to be effective apostolically. The practice of discernment is a gift that we can share with others only if we practice it.

The Society of Jesus has become a multicultural body. GC 36 was an example of this. It has been a source of joy that we have learnt to live together. We are called to another step: to grow as an intercultural body that helps to challenge and enrich our own local cultures. Each one of us can contribute with his own culture and experience, and in turn can receive from others. The

result is a universal sensitivity that transforms us into the image and likeness of God, a God who thrives on plurality and variety, in contrast with a globalization process that tries to create a uniform and standardized culture.

Another characteristic of our way of proceeding is what we call the Intellectual Apostolate. All apostolic commitments of the Society and of the individual Jesuit come from a process of discernment and must be well thought out. The big investment we have made in intellectual formation is because we want Jesuits to be able to think for themselves in any situation they are missioned to. We need to be true intellectuals within the field of Higher Education, Social Analysis or any other apostolic work. Becoming a thinker is an ongoing process. To be an intellectual is to also have the ability to proclaim the Good News in a manner that is appealing and transformative. To be an intellectual is to be an effective instrument for the apostolate.

Governance

General Principles: The government of the Society of Jesus is oriented towards the mission. It is personal, spiritual and apostolic. This is a golden principle that is not always followed. The Governance structures of the Society of Jesus were created at specific moments of history to respond to concrete mission situations. Since GC 34, the Society has been searching for a more effective structure of governance. There is a shared perception that our present structure is not effective for the mission. GC35 asked for an evaluation of the governance structures and reorganization of the Society's government. GC 36 confirmed this mandate and proposed collaboration and networking as the way of proceeding after a process of discernment.

Discernment: Discernment necessarily involves a tension between seeking and finding the will of God and apostolic planning. To seek and to find the will of God is the objective of discernment that seeks to put us at the service of the mission of Christ. Discernment is a way of making decisions that enables us to pay attention to the spiritual movements in relation to the issue that is being discerned. To pay attention to spiritual movements is to go beyond rational arguments which is a normal temptation for most of us.

Collaboration: The willingness to listen to the Spirit in discernment must, of course, include those with whom we work. They often teach us openness to the Spirit and their voices and experiences enrich our

discernment. We realize that collaboration with others is the only way the Society of Jesus can fulfill its mission. The magnitude and interconnectedness of the problems that affect humanity and challenge the mission of the Church and the Society are such, that only by working together can we contribute effectively to their solution. Along the way of collaboration, we encounter people and organizations dedicated to the service of others. Some of these share the Christian faith, others faith in God, and yet others are men and women of goodwill -- all committed to the task of reconciling humanity.

Networking: Collaboration leads spontaneously to cooperation through networks. Networks facilitate collaboration between the apostolic works of the Society and with the works of others, opening new horizons that go beyond those of a province or region in addition to mobilizing resources in support of the mission.

GC 36 (2:8) recalls some conditions for networking that involve sharing the vision of the mission. These include a “culture of generosity” as the basis of openness in collaborating with others and being effective leaders who are capable of maintaining a balance between local initiative and their own authority. GC 36 also recalls the challenge represented by the governance of Jesuit apostolic networks that go, on the one hand, beyond the works and boundaries of provinces and, on the other, those networks that are established in conjunction with other (non-Jesuit) institutions.

Apostolic Planning

Apostolic planning is an instrument for putting into action the fruits of discernment. It supposes a long-term strategy, mid-term and short-term to evaluate and reorient. A good plan is always flexible. If this tension between discernment and apostolic planning disappears, apostolic planning degenerates from being an instrument of the mission to becoming an end in itself. If this happens, it obliterates the meaning of what we are and called to do.

Planning is a way of improving the effectiveness of the mission. It is not only planning that is needed. What we are called to do is “apostolic” planning because it includes the tension between evangelization and the Ignatian magis. The aim of apostolic planning is to make present the Good News to every human being and every culture. Magis means that it is always possible to improve. We can do more and do it better if we make the best use of our resources, especially of the human

capacities of those who share the same mission, Jesuits and non-Jesuits.

Apostolic preferences are universal, for the whole Society of Jesus. But they do not constitute a plan. They are mission requirements to be considered at all levels of apostolic planning. International apostolates need to be planned as a responsibility of the universal body. Conferences are supposed to plan interprovincial apostolates and common projects under their responsibility. Therefore, a Province plan is not an attempt to accommodate a global or Conference/ Zonal plan to a local situation. Provinces plan their mission and works in a concrete territory according to the mandate received from the Superior General/the Society and the Church.

In the current organizational set-up of the Society of Jesus, a province is a unit that administers

human, economic and organizational resources for the local, regional and universal mission. The Province resources are not exclusively for a Province but for the mission of the whole Society. It



is important to recall that the Society of Jesus is not a federation of independent provinces but a universal apostolic body organized into provinces as a way of administering its resources. The Society of Jesus has been a successful administrative organization for hundreds of years because there exists an efficient system of communication and sharing of resources.

The South Asian and Latin-American Jesuits cannot forget how the Society was born in these parts. Where and how was the Society of Jesus in South Asia before the emergence of the present 18 provinces and 2 regions? Who sowed the seed and how did it grow? We exist as Jesuits in these areas because other Jesuits shared their resources.

Provinces are a provisional structure, existing side by side with other civil and church structures. If we take seriously the mandates of GC 35 and 36, we need to evaluate all the structures of our Society and, in creative fidelity, align our structures with the intuition of our Founders. There is no doubt about the important role of provinces in the Society’s governance. The question is: are other structures possible? Maybe we are arriving at a moment when we need to take seriously what we have learnt in the novitiate: we enter the Society of Jesus and not any particular province. Can we imagine other ways of organizing the apostolates in South Asia with a better use of the resources we have?

EMMANUEL RAJ ANTONISAMY, SJ

1945 - 2017

Fr Emmanuel Raj welcomed with a smile everyone who came to visit him at the hospital and kept saying, "Thank you" or "Praise the Lord." The call of the Lord came to him on 03 Feb '17 morning.

Fr Emmanuel Raj was born on 17 Dec 1945 at Pacheri, a substation of Vembattur–

Michael Pattanam parish in Sivagangai diocese. He was the eldest child in his family with two brothers and a sister. Since his father, Mr Antonisamy, was a teacher in the school at Michaelpattanam, his family settled down there. He entered the novitiate in Beschi college on 24 May 1962. A pious and prayerful novice, he was the one who volunteered to preach, whenever the novices were asked to preach an extempore sermon, when they were out on villa days.

After one year of Juniorate in Beschi, he was sent to Berchmans Hall in Chennai for his undergraduate studies.

After theology in Pune he was ordained on 02 May 1976. He was appointed the General Prefect of the Catholic Boys Boarding at St Mary's, Madurai for a year. In the following year he was the procurator and teacher at St.Mary's, Dindigul. Then he was sent to St Xavier's, Palayamkottai and he taught in the Hr.Sec. School from 1986 till May 1988. He went on to teach in the College of Education while serving also as the Director of the B.Ed. Hostel. This seems to be the time when he began to develop problems related to mental health. He was sent to Beschi Illam, Dindigul for rest. He improved and became the academic coordinator in the

M.S. University in Palayamkottai till May 2005. He was the Principal of Ansaldo College of Education in Maruthuvambadi, Chetpet from 2005 till 2012. As his health deteriorated, he was sent to St.Mary's, Madurai. In August, 2016 he became very sick and was taken to St Mary of Leuca Hospital in Moonrumavadi on 13 Aug

'16. The doctors found he had jaundice, but when he was healed of jaundice, other complications set in that affected his liver. On 20 Aug he was taken to Meenakshi Mission Hospital and kept in the I.C.U. for 8 days. The doctors said that there was no hope of his recovery and he was discharged from the hospital. He returned to St Mary's, but soon he had to be rushed to the hospital again.

He passed away peacefully in the morning of 03 Feb. His body was



brought to St Mary's at about 9.45 a.m. and a lot of people came to pay their respects. The funeral Mass began in the Cathedral at 4.00 p.m. presided by the Provincial, Fr Sebastia L. Raj. In his homily Fr Sebastian Soosai praised God for the many good qualities of Fr Emmanuel. After the Mass, Fr P.Arockiasamy, Rector, St Mary's, and Fr. Michael Jeyaraj, former Provincial, paid rich tributes to Fr Emmanuel Raj. Mr. A. Amalraj, his second brother, thanked the Jesuits, particularly those who looked after him in his last days. The final commendation was done by Fr Provincial and Fr Danis Ponniah, Rector, St.Xavier's, conducted the burial service in the cemetery. VICTOR ARULAPPAN, SJ

1945 - 2017

On 13 Feb '17, having returned after guiding a retreat, Fr Victor looked tired and complained of throat pain. At night while he was watching TV, Fr A. Joseph, Superior, Dhyana Ashram, Chennai, who was with him in the T.V. room, suggested he should sleep early and offered to celebrate the Mass next morning. Saying he will be up for the Mass, Fr Victor retired to bed. The next morning he didn't turn up for the Mass and Fr Joseph celebrated it. Initially they thought he might like to sleep longer, as he felt tired. But as time went by they decided to open the door. They found him in a sitting position near the clothes stand. As there was no pulse, they called for the doctor who, after checking, said he must have died around 5.30 a.m. of a massive heart attack.

The news of his death was received by Jesuits with shock and sadness. His funeral, originally scheduled to be held at Loyola, Chennai, had to be shifted to Beschi, Dindigul, as most of his family and relatives in and around Dindigul felt they won't be able to travel to Chennai.

Fr Victor Arulappan was born in Silukkuvaarpatti near Dindigul in 1945 and joined the Society in 1962. After completing his formation he was ordained in 1974. As part of his tertianship he undertook something few would dare to do. He got the superiors to let him live a beggar's life for a month in order to experience the reality of poverty. With no money to depend on, he wandered around dressed like a beggar, begging for his food and sleeping in public places like railway stations. He made his

last vows in 1982.

He spent 8 years at St Xavier's, Palayamkottai, as the Hostel Director, Minister, counsellor and then as Rector. He spent 8 years at the Sacred Heart Residence, Dindigul as the Regional Director of Apostleship of Prayer and editor of Thoothan, the Tamil Messenger. For 10 years he was at Dhyana Ashram, Chennai, directing retreats and counselling students at Loyola. In 2007 he became the first Chennai Mission Superior and worked earnestly for the development of the region. After his 6-year term ended he served as the Team Leader at Ranipet and then at Vadampakkam. He returned to Dhyana Ashram in 2016.



A deeply spiritual man with a strong faith, he never said no whenever he was called to celebrate the

Eucharist. A spirited and dynamic preacher, he counselled and guided married couples, youth and the religious. He readily helped a number of poor Dalits receive an education.

A large crowd of relatives, Sisters and Jesuits attended his funeral Mass on 15 Feb, presided over by the Provincial, Fr Sebastia L.Raj, who said Fr Victor's death was a personal loss for him, as he was always a friend. Fr Bosco (AND), his close relative and friend, preached a touching homily. Frs A. Joseph, Justin Emmanuel, Victor's nephew, Sr Rose, his sister and Mr Nicholas, his uncle testified to his life of faith and service. Fr Jebamalai Raja, Chennai Mission Superior, did the Final Commendation and Fr Ignacy Arockya, his nephew, conducted the burial service.

Memories

Sacred Heart & St Paul's

In 1895 the Sacred Heart College opened at Shembaganur for the novices, juniors and students of philosophy for all the ten Jesuit Missions in India and Ceylon (Ranchi, Patna Calcutta, Ahmedabad, Poona, Goa, Calicut, Madura, Galle and Trincomali). They go through their theological studies at Poona or at Kurseong in Bengal.

In 1921 Bishop Augustine Faisandier opened St Paul's Senior Seminary for the training of secular priests of various dioceses. It had over 70 students in 1936 and has already given 103 new missionaries to various South Indian dioceses.

In 1923 the number of Catholics had reached 279, 319. They had 632 churches with brick or stone walls and 456 mud-walled chapels. There were 150 Jesuit and 31 secular or diocesan priests, 39 Jesuit and 55 other lay brothers, 70 European and 382 Indian Sisters, 143 catechists and 990 elementary school teachers.

Called out of normal life

Celibacy does, in fact, take its toll upon the lives of many priests who end up unhealthy – succumbing to alcohol, a rationalized double life, gadgetry, compensating consumption, or repressed sexuality that frequently then manifests itself in the abuse of power.

What is true here for celibacy is also true for many other areas wherein religion, or anything else, asks a person to live what most others are not living. For example, in monasticism (as well as more recently in social justice circles) one sees a dark side among some: weirdness, repression of need, elitist self-righteousness, neuroses, and anger paraded as sanctity, and, as in clerical celibacy gone sour, the misuse of power.

However Goethe might aptly be quoted: "the risks of life are many, and safety lies among them." The gospel asks of us risk, to put out into the deep waters. This demand, if followed, will precisely displace us from what we would like to live as normal life. The word 'church' comes from the word *ecclesia*, from the Greek (*ek*-out of; *kaleo*-to call). To be a member of the church is to be alled out of something. What are we called out of? Precisely, normal life. Outside of a challenge from something beyond us we automatically identify what is normal with what most people are living at a given time.

The human instinct is to define the normal by idiosyncratic preference and social consensus. We need to challenge this if religion is to have an agenda that includes celibacy, social justice, or anything else that goes against what most people are in fact living.
